

**SUBSIDIARY LEGISLATION 363.83**

**PROTECTION OF *WIED ID-DIS* BRIDGE  
(GHARGHUR LOCAL COUNCIL) BYE-LAWS**

15th February, 2002

*LOCAL COUNCIL BYE-LAW 24/1/2002, as amended by Legal Notice 425 of 2007.*

**1.** The title of these Bye-Laws is the Protection of *Wied id-Dis* Bridge (Gharghur Local Council) Bye-Laws. Citation.

**2.1** In these Bye-Laws unless the context otherwise requires - Interpretation.

"Act" means the Local Councils Act; Cap. 363.

"advertisement" means any type of advertisement, including any commercial or non-commercial promotion, and includes also any other notice, notification or message printed or in writing;

"Council" means the Gharghur Local Council;

"locality" means the Gharghur locality;

"street furniture" includes any object which may be placed or fixed to the ground or placed or fixed to the wall or to any other part of the Bridge;

"the Bridge" means the bridge over *Wied id-Dis* within the locality of Gharghur, and includes the walls, fixtures and the road which runs over the bridge;

"vehicle" includes any motor car, motor cycle or any other vehicle which is used as a means of transport, whether it is a motor vehicle or not, but does not include bicycle or scooter.

**3.** No person shall, without prior written authorisation from the Council: Prohibitions.

(a) ascend or abseil, by means of ropes or other means, at any part of the Bridge;

(b) make any type of ties to the Bridge with ropes or by any other means;

(c) fix any board, banner, sticker or advertisement to any part of the Bridge;

(d) fix or place any street furniture to or on the Bridge;

(e) park any vehicle on the Bridge.

**4.** Any person who contravenes or fails to comply to any of the provisions of these Bye-Laws shall be guilty of a contravention and shall be liable, if found guilty, unless a higher penalty is applicable under any other law: Penalties.

(a) for the first contravention to a fine (*ammenda*) of forty-six euro and fifty-nine cents (€46.59);

(b) for the second or subsequent contravention, to a fine (*ammenda*) of sixty-nine euro and eighty-eight cents

(€9.88); and

- (c) in the case of a continuing contravention, to a fine (*ammenda*) of eleven euro and sixty-five cents (€11.65) for every day during which the contravention continues.

Civil damages.

**5.** The imposition of a penalty under these Bye-Laws shall be without prejudice to the right of the Council to recover all civil damages caused by the commission of any contravention under these Bye-Laws, including the right to carry out the repairs at the expense of the guilty person.

### BYE-LAWS DWAR IL-HARSIEN TAL-PONT TA' WIED ID-DIS (KUNSILL LOKALI GHARGHUR)

*KUNSILL LOKALI BYE-LAW 24/1/2002, kif emendat bl-Avviz Legali 425 ta' l-2007.*

1. It-titolu ta' dawn il-*Bye-Laws* hu *Bye-Laws* dwar il-Harsien tal-Pont ta' Wied id-Dis (Kunsill Lokali Gharghur). Titolu.
2. F'dawn il-*Bye-Laws* kemm-il darba r-rabta tal-kliem ma tehtiegħ xort'ohra: Tifsir.
  - "Att" tfisser l-Att dwar Kunsilli Lokali; Kap. 363.
  - "għamara tat-triq" tinkludi kull oġġett li jista' jitqiegħed jew jitwahħal ma' l-art jew li jitpogġa jew jitwahħal mal-hajt jew ma' xi parti ohra tal-Pont;
  - "il-Pont" tfisser il-pont ta' fuq Wied id-Dis ġewwa l-lokalità tal-Gharghur, u tinkludi l-hitan, l-attrezzaturi u t-triq li tghaddi minn fuq il-pont;
  - "Kunsill" tfisser il-Kunsill Lokali Gharghur;
  - "lokalità" tfisser il-lokalità ta' l-Gharghur;
  - "reklam" tfisser kull xorta ta' reklam, inkluża kull promozzjoni kummerċjali jew mhux, u tinkludi wkoll kull avviz, notifika jew messaġġ ichor stampat jew bil-kitba;
  - "vettura" tinkludi kull karrozza, mutur jew xi vettura ohra li tintuża bħala mezz ta' trasport, kemm jekk tkun vettura bil-mutur u kemm jekk ma tkunx, iżda ma tinkludix *bicycle* jew *scooter*.
3. Hadd ma għandu mingħajr il-permess minn qabel bil-miktub tal-Kunsill - Projbizzjonijiet.
  - (a) jitla' jew jinżel, permezz ta' hbula jew mezz ohra, ma' xi parti tal-Pont;
  - (b) jagħmel xi tip ta' rbit mal-Pont permezz ta' hbula jew mezz ohra;
  - (c) iwahħal xi tabella, *banner*, *sticker* jew reklam ma' xi parti tal-Pont;
  - (d) iwahħal jew ipogġi xi għamara tat-triq ma' jew fuq il-Pont;
  - (e) jipparkja xi vettura fuq il-Pont.
4. Kull persuna li tikser jew tonqos li thares xi wahda mid-disposizzjonijiet ta' dawn il-*Bye-Laws* tkun hatja ta' kontravvenzjoni u tehel, meta tinsab hatja, sakemm ma tkunx applikabbli piena oghla taht xi ligi ohra: Penali.

  - (a) għall-cwwel kontravvenzjoni ammenda ta' sitta u erbghin euro u disgha u hamsin ċenteżmu (€46.59);
  - (b) għat-tieni kontravvenzjoni jew għal kull

kontravvenzjoni ohra li ssir wara, ammenda ta' disgha u sittin euro u tmienja u tmenin ċenteżmu (€69.88); u

- (ċ) fil-każ ta' reat kontinwat ammenda ta' hdax-il euro u hamsa u sittin ċenteżmu (€1.65) ghal kull jum li matulu jkompli r-reat.

Danni ċivili.

**5.** L-ghoti ta' piena taht dawn il-*Bye-Laws* jkun bla hsara ghall-jedd tal-Kunsill li jiġbor id-danni ċivili kollha li jkunu saru bl-ghemil ta' xi kontravvenzjoni taht dawn il-*Bye-Laws*, inkluż id-dritt li jaghmel it-tiswija meħtieġa bi spejjeż tal-persuna misjuba hatja.
